7. CFIFF-25 stages/process:

- Entry submission as per rules & regulations.
- Notification of shortlisted films by the festival office on 03 June 2025 and late submission notification on 07 June 2025.
- Delegate registration to attend CFIFF-25. All filmmakers must have registered as delegate to attend the festival. Hospitality charges are applicable for filmmakers & attendees, which include lunch, tea/coffee with cookies & master classes.
- Festival movies screening & workshops followed by award ceremony on 29 June 2025 at Goa, India.

8. Cinema Father International Film Festival-2025 does not take any type financial commitment for the expense incurred on the correspondence by the participant. All Travel, Lodging & Boarding and other miscellaneous expenses will have to be borne by the participant himself for attending the festival. No request for the same will be entertained.

9. The actual postal charges are applicable for award delivery via courier in case you are unable to attend the festival.

10. Once the film submitted can't be withdrawn in any circumstances, however festival director reserve the rights to disqualify any film on certain grounds.
